A. CALL TO ORDER

Mr. McElligott determined that the attendance of Supervisors Joseph Sweeney, Shana Horvath, and Olivia Thayer constituted a quorum, and it was in order to proceed with the meeting.

D. ADDITIONS OR DELETIONS TO THE AGENDA

Mr. McElligott noted that since both the Chair and Vice Chair we absent, it was in order to elect a Chair specifically for this meeting from the Board Members present.

There was a **motion** made by Mr. Sweeney, with a second from Mrs. Thayer, to elect Mrs. Horvath as Chair for this meeting. That **motion** passed **3-0**.

They will then need to check the box on the Form 1 next year saying they completed the 4 hours this year.

Mr. McElligott explained to the Board that there is a new, online only format for the Form 1 starting this year. The Board members should see an email from the state in the coming months so they can register and complete the form.
