A. CALL TO ORDER

District Manager Michael McElligott called the September 17, 2025, Regular Board Meeting of the Renaissance Commons Community Development District to order at 1:39 p.m. in the Conference Room of Compson & Associates, 1075 Broken Sound Parkway, Suite 103, Boca Raton, Florida 33487.

B. PROOF OF PUBLICATION

Mr. McElligott presented proof of publication that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on November 11, 2024, as legally required.

C. ESTABLISH A QUORUM

Mr. McElligott determined that the attendance of Chair Robert D'Angelo, Vice Chair Carl Klepper, and Supervisor Shana Horvath constituted a quorum, and it was in order to proceed with the meeting.

Also present were District Managers Michael McElligott of Special District Services, Inc., and District Counsel Michael Pawelczyk, from Billing, Cochran, Lyles, Mauro & Ramsey, P.A., and District Engineer Jeff Schnars, from Schnars Engineering Corporation, via phone.

D. ADDITIONS OR DELETIONS TO THE AGENDA

Mr. McElligott informed the Board that he had received a resignation letter from Olivia Thayer due to her moving out of the area. There was a **motion** from Mr. Klepper, with a second from Mr. D'Angelo, to accept the resignation of Ms. Thayer and declare seat 1 vacant. The **motion** passed **3-0**.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. May 21, 2025, Public Hearing & Regular Board Meeting

Mr. McElligott presented the minutes of the May 21, 2025, Public Hearing & Regular Board Meeting. Without comment, Mr. Klepper made a **motion**, seconded by Mr. D'Angelo, approving the minutes of the May 21, 2025, Public Hearing & Regular Board Meeting, as presented. Upon being put to a vote, the **motion** carried **3 to 0**.

G. OLD BUSINESS

There was no Old Business.

H. NEW BUSINESS

1. Consider HOA Repairs Request

Mr. McElligott explained the requests he had received from the HOA for repairs related to CDD owned roads and some paver repairs. District Engineer Mr. Schnars went over some pictures and the repairs needed. After some discussion, there was a **motion** by Mr. Klepper, with a second from Mr. D'Angelo to authorized the Engineer to get proposals on the road repair and to proceed with the repairs at a not to exceed amount of \$10,000.00, and to authorize the HOA to get proposals to do the paver repair and proceed with repairs after approval of the District engineer with a not to exceed amount of \$20,000.00. The **motion** passed **3-0**.

2. Consider Resolution No. 2025-05 – Adopting a Fiscal Year 2024/2025 Amended Budget

Resolution No. 2025-05 was presented, entitled:

RESOLUTION NO. 2025-05

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE RENAISSANCE COMMONS COMMUNITY DEVELOPMENT DISTRICT AUTHORIZING AND ADOPTING AN AMENDED FINAL FISCAL YEAR 2024/2025 BUDGET ("AMENDED BUDGET"), PURSUANT TO CHAPTER 189, FLORIDA STATUTES; AND PROVIDING AN EFFECTIVE DATE.

Mr. McElligott reviewed the Amended Budget with the Board members. After a brief discussion, a **motion** was made by Mrs. Horvath, seconded by Mr. D'Angelo, and **passed** unanimously to adopt Resolution No. 2025-05, as presented.

3. Consider Resolution No. 2025-06 – Adopting Goals and Objectives Annual Report

Mr. McElligott presented Resolution No. 2025-06, entitled:

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE RENAISSANCE COMMONS COMMUNITY DEVELOPMENT DISTRICT ADOPTING AN ANNUAL REPORT OF GOALS, OBJECTIVES, AND PERFORMANCE MEASURES AND STANDARDS; PROVIDING A SERVABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.
